City of Union City Request for Proposals from Law Firms Interested in Serving as "General Counsel to the City of Union City Rent Stabilization Board" for the period January 1, 2026 through December 31, 2026

Introduction

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the City of Union City ("City") seeks proposals in response to this Request for Proposals ("RFP") from law firms licensed to practice law in the State of New Jersey that wish to provide general counsel and litigation services to the Union City Rent Stabilization Board ("Board"), as directed by the Corporation Counsel, the Board or other appropriate official within the City for a contract period from January 1, 2026 through December 31, 2026. All candidates are required to comply with N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action, see Exhibit A attached hereto). Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract, but preferably with their proposal. The successful firm must have significant experience in representing New Jersey municipalities with respect to Rent Leveling issues. The successful firm will provide the Board with legal guidance relating to, but not necessarily limited to:

- Legal research and/or advisory opinions as needed;
- 2. Represent the Board in federal and state courts and administrative forums;
- 3. Review, analyze and advise the Board on any application before it;
- 4. Review and/or draft resolutions and ordinances;
- 5. Attend meetings of the Board;
- 6. Attend meetings of the City Commissioners upon request;
- 7. Conduct programs on Board issues for appropriate elected officials, city employees, Board members or other persons upon request;
- 8. Notify the City and the Board of changes in the law or regulations, as well as Court decisions, that impact the City and the Board; and
- 9. Any other matters as directed by the City or the Board.
- 10. The vendor shall provide monthly billing statements that include a brief statement showing the original amount of the Contract, any increases established by amendment to the Contract, the amount previously billed under the Contract, and the total amount of unbilled funds remaining available under the Contract, and the total amount of unbilled funds remaining available under the Contract after deduction of the most recent amount billed. A copy of each billing statement shall be made available to the State Fiscal Oversight Officer upon request.

Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal, and must comply with the Affirmative Action requirements contained at N.J.A.C. 17:27 *et seq.* (See Exhibit A attached hereto).

Proposers are advised that the contract with the successful proposer will permit the City to make payments to the successful proposer for approved services in accordance with, and within the time permitted by, the law governing prompt payment of public contracts for the purchase of goods and services.

The selection criteria used in awarding a contract or agreement for professional services as described herein shall include:

- 1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation;
- 2. Experience in representing Rent Leveling Boards, other Boards of a public entity and familiarity with landlord/tenant issues substantially similar to Union City in urban environments and references;
- 3. Ability to perform the task in a timely fashion, including staffing and familiarity with the subject matter;
- 4. Ability to be available with the appropriate personnel at all times necessary to accomplish the representation;
- 5. The cost and expense that will be necessary to familiarize the attorney with the municipal issues pending before the Board; and
- 5. Cost competitiveness in light of all of the above factors.
