- Application must be filed with the Chief of Police of the City of Union City not less than 30 (thirty) days before the date on which the proposed Parade/Procession shall be conducted. The chief of Police has the option of requiring that a meeting with Parade/Procession promoters be held before permission for Parade/Procession is granted.
- Submit a check or Money order payable to the City of Union City in the amount of \$5.00 for the permit fee.
